### REGIONAL OFFICERS CONFERENCE REPORT

Increased visibility and awareness of the CPCU designation was again a major focus of the Northeast Regional Officers Conference. The conference, attended by Chapter Officers Pete Palestina, Vince Phillips, Phil Spinelli, and Steve Graves, was hosted by the Baltimore Chapter, CPCU. Preceding the two-day conference was a one-day public relations workshop, which was also attended by Palestina, Phillips and Spinelli.

Over the past two years, the Chapter has made a significant effort to improve its public relations efforts. The attendance at the workshop should help to improve our performance.

One of the exciting new programs coming out of National will be a series of public service announcements which will feature the dynamic voices of John Facenda and our own Ed Harvey. The first series of these announcements will carry an arson awareness message. We plan to optimize the usage of these public service announcements as part of our CPCU visibility and awareness objective.

Also being made available is a film entitled "Report to Consumers." This documentary dramatically illustrates the contributions of insurance to the well-being of society. This film should enhance the capability of our speakers bureau.

The two-day officers conference revolved around four functional workshops, all structured to give vitality and support to the Society of CPCU. The workshop themes were:

 A progressive organization, which dealt with the establishing of long and short-term goals.

- Industry participation, involvement and contributions to industry and business activities.
- Fostering professionalism in insurance and risk management.
- CPCU visibility, promoting CPCU within the industry and business so that it is more readily recognized in terms of its professional stature.

As you will note in the President's Message, we have made significant accomplishments as a Chapter, but there is still lots to be done. The participation at the Regional Officers Conference will give us additional impetus to move forward.

### BREAKFAST MEETING UPDATES:

Efficiency in operations was the theme of the address of David J. Prentiss, CPCU, (pictured below), at the December 16th Breakfast Meeting. Efficiency will be the cornerstone for both company and agency operations during the 80's, for only the most efficient will remain as a viable factor in the market-place. And, the thrust for this change will come from the agents themselves. As they become more efficient in response to marketing conditions, they will demand better performance from their companies.

Mr. Prentiss, head of the CIGNA P & C Retail Division, also discussed the merger process between INA and C.G., and the positioning of the combined organization in the financial services marketplace.



#### January 27:

A Grant Sprechter, Esq., head of the litigation department of Obermayer, Rebmann, Maxwell and Hipple, addressed the January 27th breakfast His topic dealt with legal issues meetina. associated with the health care delivery systems. Medical malpractice awards have continued to increase and incidents involving large suits or judgments are eagerly reported to the media but judgments favorable to the defendants are literally ignored, stated Sprechter. The more sophisticated the health care delivery system becomes, the higher the standard of care expected from the medical profession. Hence, the potential for legal action is increased. Practically speaking, the public is not overly sympathetic to most defendants.

In spite of this scenario, malpractice claims are defensible. Education is the key. Practitioners, in concert with their insurance advisors, should go through an annual legal check-up to minimize severity through procedural controls and to eliminate gaps in coverage.


