A t its July 15th board meeting the chapter board of directors approved the following preliminary budget and was approved for the chapter year July 1, 1998 to June 30, 1999.


The final adopted budget is expected to be approved at the board's September meeting.

## **May Meeting Recap**

"Reinsurers Going to Hell in the 21st Century?"

The entire Philadelphia Sedgwick Re Casualty Facultative Staff sat posture perfect politely nibbling on their bacon and eggs. Our May breakfast meeting was blessed with a variety of reinsurance celebrities but how unusual to see the Sedgwick crowd before noon! We were all baffled until our guest speaker was announced, Jon Goodman, Sedgwick Re National director of Casualty Facultative Insurance.

Jon addressed the issue of the future role of reinsurers in the 21st century. The reinsurance marketplace has been softening due to a number of reasons such as the lack of catastrophes, high investment returns, tort reform and reconstruction and revitalization of Lloyd's. Mergers and acquisitions have resulted in increased capitalization of primary carriers leading to an increased net retention of risk. Are reinsures going to get squeezed out of the picture? Simply answered-the extinction of reinsurance is not going to happen. Reinsurers have been turning the world of insurance for a century. A few of the current needs for reinsurance include capacity, natural disasters, asbestos and environmental issues. However, insurers may become more selective in choosing their reinsurance part-

Insurer's want solid reinsurers. Today's sophisticated reinsurers are underwriting their reinsurer's financial integrity. One of the greatest threats to a reinsurer's financial stability continues to be past liabilities from asbestos and environmental pollution. A diligent reinsurance purchaser now inquires what effect these past liabilities will have on the reinsurer's future balance sheets. The insurer wants to know the strength of the reinsurer's loss reserves. Determining the adequacy of loss reserves often requires significant due diligence considering some of the alternative reasons for suppressing reserves (i.e. financial rating, stock price, acquisition, etc.)

Jon predicted consolidation and intense competition within the reinsurance market into the 21st century. There will be fewer and larger reinsurers competing not only for domestic business but for foreign business as well. A "globalization" plan will be essential in obtaining and maintaining superior financial strength via worldwide growth and spread of risk. The larger reinsurers will lose interest in servicing small clients and the small reinsures will become "niche" players. Strong personal relationships will play less of a role in closing business transactions as the pressure to appease shareholders increases. Look for more flexibility in reinsurance products. Expect to see finite risk placements, financial products and products that blend treaty and facultative programs emerge from the reinsurance marketplace. Although reinsurers will become larger and financially stronger, the availability of catastrophe protection may be reduced due to fewer players in the industry.

The distribution and marketing of reinsurance may change during the next century. Currently, most reinsurers choose to market their product either directly using their own employees or through an intermediary. Reinsurance intermediaries, who represent numerous reinsures, have seen their markets shrink as insurers whittle their list of approved insurers. Jon believes some direct market reinsurers may abandon the direct only philosophy and accept business from any source.

The year 2000 issue may also play a significant part in determining the role of reinsurers in the 21st century. The ISO year 2000 exclusions are out, approved in some states but not all. Some insurers have decided to attach year 2000 exclusions to exposed coverages, some have not, many simply have not made up their minds yet and a few are even marketing a year 2000 coverage. Reinsurer's attitudes seem to be just as diverse regarding this exposure as insurers.

Are reinsurers going to hell in the 21st century? Yes, one could argue, unless they get off the tracks!

#### 1997-98 ANNUAL REPORT TO CHAPTER MEMBERSHIP

The President for the 1997-98 Chapter year was Anne M. Kopanski, CPCU.

The Philadelphia Chapter prepared to "Influence the Future" during this year. We accomplished outstanding results. The board started the year discussing filing for various National committee awards and the Society's President's award as what we should accomplish as your elected officials for our chapter. The Chapter Planning and Activity Report was completed and filed with National. We have filed for various committee achievement awards and some committees have even filed for the excellence (highest) award they can achieve within their category.

Several members and new designees represented the Chapter at the National Convention in Dallas this past fall. We hosted a hospitality suite for the new designees and any attending members. At the conclusion of the convention, we found out that we had won six awards for the work our committees had done in the prior year (1996-1997).

We sent two officers to the Chapter Officers Leadership Council - a forum where they pick up ideas and contacts to help them lead our Chapter. The Board set up a Chapter's Future Committee, to work on future strategic goals and objectives, to guide us into the future. Our members, officers and directors are challenged by changes in the insurance profession in the 90s. We are affected by restructuring, careers in transition, founding new business; all with elongated work hours and hectic travel schedules. Our officers and directors are challenged by distance with an average of a 45-minute commute to get in a central location. We explored meeting by teleconference to accommodate an additional meeting. Many of our officers commute two to three hours a day. The net impact is reduced availability to carry out the increasing criteria forever-growing number of required award activities.

We have seen a substantial increase in the number of participants in many of the activities we conduct (e.g., the average attendance increased at the breakfast program by 30% over last year). During the breakfast programs, we started selling 50-50 tickets, the proceeds of which will go to donations our Scholarship Committee suggests.

We continue to sponsor and conduct many highly successful major events including Philly I-Day, The Franklin Award, the 15th Annual Fire Essay Contest in Bucks County and the 5th Annual Fire Essay Award in Philadelphia, and partner with the Insurance Society of Philadelphia and Independent Insurance Agents to host Philly I-Day.

One last activity we proudly accomplished this year was funding, authoring and presenting the Project InVEST Workshop for teachers. The success of the Workshop can be measured by the fact that three schools are committed to implementing the program in their school districts. Project InVEST is a business simulation based on an insurance company ad agencies organized to sell personal automobile insurance. Success is measured at Germantown High School, who hosted the workshop, by 95% attendance at a 7:15 a.m. InVEST class, compared to 35-45% average attendance in other classes.

#### **CHAPTERGRAM**

Peter F. Palestina, CPCU, Editor of the Chaptergram since 1983, published four issues (eight pages each) which were distributed in September '97, December '97, March '98, and June '98. In addition, two two-page interim Chaptergrams were published, one in February 1998 and May 1998. These issues were mailed piggyback with monthly meeting mailings in order to save postage. Compliments from both internal and external readers are made about the Chaptergram; ours is used as a model for other chapters.

#### CHAPTER OFFICERS' LEADERSHIP CONFERENCE

The Society's COLC for our Chapter region was held by the National Society. This two day conference was attended by first Vice President Sandra Loebs, CPCU who attended East Coast and Secretary Val Ullman-Katz, CPCU, who attended West Coast Conference.

#### DIRECTORY

Keeping with the three-year tradition, we are in the process of publishing our Chapter's directory of members so each member will receive one. The Directory is published on a three-year cycle due to the printing costs of close to \$2,000.00. This will be a priority in the coming year.

#### FIFTIETH ANNIVERSARY

Under the direction of Art Hanebury, CPCU, and T.C. McDonnell, CPCU, the committee co-chairpeople, the committee started its celebration of our Chapter's fiftieth anniversary. As of this writing, we heard about our chapter and insurance history during our Chapter's 50 year history. The final gala was I-Day, a reception in the late afternoon. A logo and large banner were created. Past presidents were invited to attend our Franklin Awards. We also have a list of all the officers and directors of our chapter since its inception.

#### FIRE ESSAY CONTESTS

We held our 15th annual "Fire Safety in the Home" essay contest cosponsored by the Council Rock School District located in Bucks County. The essays were written during National Fire Prevention Week. Peter F. Palestina, CPCU, chairs this contest. Awards were presented to the winning elementary students on November 20, at the Council Rock Board meeting and November 25th, at the Northampton Township Board of Supervisors public meeting. Elected officials of Northampton Township, Newtown Township and Newtown Borough presented citations to the winning students, who reside in the respective municipalities. Both meetings were broadcast live over the local cable network to five municipalities. Peter F. Palestina, CPCU, and Anne M. Kopanski, CPCU, made the presentations.

We held our 4th annual "Fire Safety in the Home" essay contest cosponsored the School District of Philadelphia on May 28th at the Districts' officer's boardroom. Shiang Wu, CPCU chairs this contest. Wade Communications also assisted in this event. On hand for the presentation were Shiang Wu, CPCU, and Anne M. Kopanski, CPCU.

#### GOOD WORKS

Cynthia Gantz, CPCU chaired the Committee which again participated in the May Philadelphia Special Olympics held at Northeast High School in Philadelphia. The committee for the second year in a row, conducted a Holiday charity drive which brought in over monetary and packaged gifts which the Chapter donated to Big Sisters of Philadelphia, Inc.

Anne Kopanski, CPCU, chairman of Project InVEST, co-authored grant proposals, wrote and delivered a two day workshop for school teachers to increase interest in this excellent school to work program. The session was attended by Barbara Miller Richards, National Coordinator Project InVEST. Germantown Project InVEST will be the cover story for the Independent Agent Magazine in September.

#### MEMBERSHIP

The membership committee, headed by Rina Williams, CPCU, met monthly. Some of their accomplishments this year included: Acquiring correct names and addresses for publication of the Chapter directory; telephoning to solicit dues from potential Chapter members. Our number of paid members increased this year because of the encouragement of Rina and her committee members "Buddy" system will begin in the Fall that will help newcomers to meet and network with members.

#### **NEW DESIGNEES**

The new designees were welcomed to our Chapter in personalized letters after their completion of the CPCU program. They were also invited to one of our breakfast programs, free of charge. At I-Day, we recognized their accomplishment with the local conferent; and followed up with this by publishing their name in our Chaptergram.

The chapter again joined with the Independent Agents of Philadelphia and it's suburbs, and the Insurance Society of Philadelphia to sponsor Philly I-Day held on October 16, 1997. There were approximately 400 participants. Maria Perez-Freedman, CPCU, chaired this event. Continuing Education credits were instituted this year. New designees were recognized by a local conferment held at the luncheon. Larry Gross, CPCU, is now the co-chair with chairmanship next year. There have been meetings to revitalize this event and formalize the understanding between the various organizations as to what is expected of them as participants in this event.

#### **PROGRAMS**

Bernadette Fuller, CPCU, organized Programs this year. There were eight given this year and the average attendance increased by over 30%. The excellent activity provides a great means for networking and learning about current events in insurance. Dr. Norm Baglini presented our Ethics Awareness Program. At that program we presented Norm with a Resolution honoring his 25 years of dedication to our profession. Season tickets are available and that makes it easier for member or guests to attend.

We successfully receive Continuing Education Credit from the Pennsylvania Department of Insurance in getting a few of these meetings approved for continuing education credit, as a way to attract more agent members.

#### PUBLIC RELATIONS

The Chapter's public relations committee plays an important role in: securing public recognition for chapter activities, advising the public through the news media of important events, and gaining recognition for the CPCU designation. The committee sent out press releases, recorded a number of speaking engagements, reported on fire essay contests this year for two school districts, had a few articles published in local publications. Chairperson Larry Gross, CPCU, also reported on the press releases for the I-Day, fire essay contests and Project InVEST Workshop.

#### RESEARCH

A Chapter research project entitled "Do You Hear What I Hear?" was published in May, 1997. Presentation work on this project continued over the summer. Interest continues to grow in the results. This addressed the impact of jargon on the relationship between the insurance industry and their customers. The author is Larry Gross, CPCU, and his contention is that the works we speak, the language or jargon of the insurance industry creates an environment where communication goes wrong and meaning is distorted. The result of this is that people form strong negative emotions about the messengers, despite the fact that the insurer, the producer of other insurance professionals might do everything correctly. The objective of this project was to establish this premise and support it by literature review of other industries that have their own language (information systems, technicians, politicians, journalists, etc.) He cites how others outside these cultures react to them and look to see where there might be anecdotal evidence to tie together any similarities to the industry.

### June Meeting Recap

#### Exposures in the 21st Century

The June Chapter meeting provided an interesting look at prospects for exposures in the 21st century. Angel Edmond, CPCU and Steve Harris combined to make an excellent presentation. They looked at three trends that will affect exposures: globalization, tech-

nology, and consolidation.

Globalization was considered as the "most important factor in economic development". They saw exposures developing as companies expand their operations into foreign locations. The new exposures will deal with the physical offices, an increased demand for travel accident coverage, and contingent business interruption.

Technology will create a number of new exposures. Edmond and Harris centered on increased demand for coverage relating to EDP software and systems in two areas: failure of the software (proprietary) and equipment (especially at dependent premises) and in the area of theft. They also projected heightened exposures in Internet-related commerce, workstation ergonomics, and the telecommuting arena.


The area of consolidation was their final point. They began by noting that consolidation is increasing because of the availability of financing, investor pressure, perceived efficiencies, and the overall regulatory attitude towards mergers. The increased level of consolidation will result, according to Edmond and Harris, in demand for coverage in suites over new acquisitions (which could result in stockholders suites as they debate whether the best offer was taken), representations and warranties, and suites brought because of downsizing and other employment practices.
