The question concerns the two (2) at-large governors. Must these two governors be an active CPCU or could they be non-CPCU like a business executive inside or outside the insurance industry? There is debate both ways, and I would like to hear your comments.

At the mid-year meeting, April 9-10, 1999 in Chicago, the Board of Directors will vote on the New Governance Structure for the Society. January Moesting Recareer

n January 21, 1999, attendees of the CPCU Breakfast Meeting had the pleasure of hearing Mr. John P. Creveling of Career Resources Management in Philadelphia to discuss change and career management. Mr. Creveling made a dramatic entrance, dressed in historical garb, introducing himself as John "Patrick Henry" Creveling. This provided a segue in to his discussion on change. The nature, implications and reactions to change experienced by our forefathers (hence the Patrick Henry costume) differ little from those experienced today.

Mr. Creveling advised the group to prepare for change, and to accept it. One may prepare for change by taking responsibility for and managing his/her career, which will make them more marketable and employable.

In the workplace of yesteryear, change was not as prevalent. Years ago, a career plan involved "climbing the career ladder, keep working, retire gracefully, then collect a pension." In today's rapidly changing environment, with changes in technology, the global marketplace, consolidations, mergers, and acquisitions, that career plan is no longer viable. Rather, we must become "self-reliant" in our careers.

Becoming "self-reliant" entails having a career plan with direction and focus. Mr. Creveling provided a listing of sixty-seven "Core Competencies" (i.e., creativity, organizing, listening), and asked everyone to choose five which were reflective of each person's strengths. Then, each table as a group chose three core competencies that they thought were necessary for success in the insurance industry. A comparison of each person's strengths and skills with those necessary for success in the insurance industry provided insights into potential areas for professional development. The object of this exercise was to "align one's career plan with the market."

As for professional development, Mr. Creveling said that 70% of executives' development occurs on the job, 20% through people, and 10% through coursework. A mentor or coach from inside or outside of your organization is instrumental to one's development. He also advised the group to become "perpetual students," and strive to keep current, such as with industry and technological developments.


In closing, Mr. Creveling encouraged everyone to take responsibility for his/her career. Change is inevitable, but if we learn to respond to it effectively and positively, it may yield new opportunities.

Prior to Mr. Creveling's presentation, Clint Gillespie, CPCU, our Chapter's Personal Lines Section Chairman, addressed the members in attendance. Clint volunteered to bring Section information to each Breakfast Meeting. On behalf of the Society, Clint will try to encourage interest sections within our Chapter. He advised that there may be additional redesign around the Sections within the Society. Two other members of the Personal Lines Section Board of Directors are Philadelphia Chapter members. They are Charles Butler, CPCU and Kathleen M. Frenzel, CPCU.

In addition, as well as at the Chapter Board of Directors meeting, Clint spoke on the video produced by Keystone, *Take Five, Stay Alive*. The video is intended to explain the purpose of a new educational "club" for young drivers aged 14-20. The goal of Keystone is to obtain corporate sponsors and teach young drivers about ownership, maintenance and operation of a vehicle. Structured similarly to a 4H club, Clint is hopeful that the state of Virginia will accept this program which would be one hour a week in lieu of their current driver education program. Keystone would give a premium discount to participants. Clint finished by mentioning that the program has been endorsed by the Pennsylvania State Police Department.


Philly I-Day

"Risk Management for Public Entities", a new Course Offered by the Institute

n February, a new course was introduced by the Insurance Institute entitled "Risk Management for Public Entities." IIA, in cooperation with the Public Risk Management Association (PRIMA), released the course designed for risk managers employed by public or other non-profit entities. It is also of interest to other public officials with some risk management responsibilities, insurance brokers or agents specializing in public sector accounts, insurance company public sector specialists, and consultants. According to the Institute, the course will focus on the distinctive features of public-sector risk management, or how risk management for public and other non-profit entities is special. Public entities are either organizations that have governmental powers or that support such organizations such as electric companies, hospitals, parks authorities, etc., depending on the ownership and how they are chartered. Although the course builds on the content of the ARM program, holding the ARM designation is not a prerequisite. The course culminates in a three hour exam, which is available on request. People who pass the exam earn a Certificate of Completion. The course was developed by George L. Head, Ph. D., CPCU, CLU, Institute Vice President, and Kwok-Sze Richard Wong, deputy executive director of PRIMA.

I must say that I was very excited when I read about this new course. Aside from my livelihood as an insurance broker, I am also an elected public official (Supervisor in Northampton Township). I can tell you that every municipality is involved with some kind of insurance protection, be it traditional or self insurance. In most cases, the decision to purchase, arrange or recommend coverage is in the hands of the township manager. He or she will be comparing bids from several companies and brokers or will be evaluating proposals or making decisions from recommendations made by a Board of Trustees who oversee some joint self insured programs. This would be a great opportunity for them to better their knowledge of what risk management is all about, assuming they have any knowledge of the subject whatsoever. You can do yourself, your township officials and your citizenry a favor, by letting them know that this new course is available and worth their investment. I took the time to make this known to the Trustees of the 26 or so municipalities that make up the particular self insured group I am affiliated with. Hopefully, they will avail themselves of this great opportunity to enhance their insurance knowledge.

f someone had asked me less than a year ago where Albany, New York was I would have said somewhere up north where it snows a lot. You know, Buffalo, Syracuse, Rochester. Winter sports are popular here. I tried downhill skiing once in my adult life. After going downhill I knew it would have been better if I had tried this sport during my adolescence or sooner. Snowboarding is not a consideration for me. But, I haven't ruled out the cross country skiing.

Finding my way around town was a bit of a challenge at first. It was confusing to me to go south on the Northway. I finally got the hang of it. Once I got that straight everything began to fall into place.

It wasn't difficult to find the local CPCU Chapter here. I attended the annual Christmas luncheon of Professional Insurance Groups. Groups such as PIA, Professional Insurance Women, CPCU participate. For the past five years the groups have pooled their money and resources to present a check to the Regional Food Bank during the luncheon. Volunteers are solicited at the luncheon to sign up three hours of their time to collect donations from the public at an exhibit table in the mall. The funds collected by the insurance group volunteers are matched by a group of corporate food bank sponsors. The event created an atmosphere of fun, networking and synergy.

I have made some friends, and met a number of business contacts in the area, but my thoughts reflect back to Philadelphia. Some of my fondest memories are of the Philadelphia CPCU chapter, and its board. November 1998 Meeting Recap

he November speaker was John W. Roblin, senior V.P. and Information Systems Officer for CIGNA Property and Casualty. Mr. Roblin presented a very informative picture of some of the information technology issues facing the industry today. This included some very humorous anecdotes such as: "Amazon used to be a river." He also noted that in 1977, the Chairman of Intel stated at a business meeting that he could not figure out why anyone would need a personal computer at home - how times change!

With respect to the P&C industry, some of the systems related issues reviewed were those connected with keeping all systems operations in-house; the drain of resources caused by Year 2000 related issues; and recurring problems related to the use of legacy type systems.

One of the most important points brought out in Mr. Roblin's talk was the fast pace of change within the industry, particularly within the systems and information technology areas. He further pointed out that it is important for companies to recognize this as a constant, which needs to be managed.

Throughout his presentation, Mr. Roblin used quotes from Yogi Berra to reinforce many of the points being made. The final and most appropriate quote was: "The other team could make real trouble for us if they win."

Candidate Recruitment and Development

he committee is preparing to send a letter to the Society listing CPCU candidates in an attempt to learn who among the current candidates would prefer a Personal Sponsor. We recognize that only by perpetuation of the designation, through the attainment of the designation by additional insurance professionals, can we thrive. The Committee seeks to encourage insurance professionals to begin the CPCU program by providing information at industry meetings such as I-Day and corporate career days.

The program of study for the CPCU designation is rigorous. Adults, particularly those out of school for a while, may need encouragement at various stages during the course of study.

The Personal Sponsorship has been designed by the Society to team up CPCU candidates with Chapter CPCUs. The Sponsor offers guidance throughout the program, invites the candidate to participate at the Chapter meetings, and encourages the candidate to persevere.

Once the Candidate has completed the course of study and achieved the designation, she/he may nominate her/his Personal Sponsor for the Personal Sponsorship Award recognizing the Sponsor's contribution to the candidate's success.

The Committee has held an *Evening of Wine and Cheese and Test Tips* for candidates. At this wine and cheese hour, Institute graders presented some time honored tips for success on exams.

The Committee hosted an evening for Sponsors to discuss strategies for encouraging candidates to continue, especially when the candidate has "stubbed a toe."

The Society has charged the Chapter Committee to match sponsors and candidates. By Spring, we hope to have this task completed. The Candidate Recruitment and Development Committee will then host a "Meet Your Candidate/Sponsor Night."
